Northern Lakes Seafood & Meats is authorized to obtain any information considered necessary from any source concerning the statements of this application.

The Purchaser named on the reverse side of this Credit Application Agreement agrees that all purchases made by the Purchaser or by any person representing himself to be an employee, agent, or representative of the Purchaser from Northern Lakes Seafood & Meats and its subsidiaries, affiliates, and division (the "Seller") shall be subject of the credit terms and conditions of the Seller as established and amended from time to time, including the terms and conditions set forth herein. The Purchaser represents and warrants that the information furnished herein authorizes Northern Lakes and Meats to investigate and obtain information from all the bank and other credit references and sources (whether or not listed in this Credit Application and Agreement) regarding the Purchaser's credit worthiness. All credit extensions shall be made at the sole discretion of the Seller and may be denied, altered or terminated by the Seller at any time without cause. In the event of any change to the Purchaser's account before the Seller reserves the right to require any such successors to submit a new credit application prior to any extension of credit to such successors.

The Purchaser agrees to pay all amounts due to the Seller in full in accordance with the terms stated on each invoice. Any amount not paid when due to the Seller shall bear interest at the rate of eighteen percent (18%) per annum or the maximum lawful rate (whichever is less) until paid. A service charge will be payable by the Purchaser for any check returned by the Purchaser's bank. Northern Lakes Seafood & Meats does not waive any additional remedies available under applicable state laws for any returned check by the Purchaser's bank due to insufficient funds. The Purchaser shall pay all attorney's fees, collections and court costs and other expenses incurred by Northern Lakes Seafood & Meats to collect any obligations owing by the Purchaser, whether or not incurred in connection with litigation. The Purchaser agrees that the venue of any action to enforce this Credit Application and Agreement shall, at Northern Lakes Seafood & Meats' option, be in the county in which Northern Lakes Seafood & Meats' branch that supplies the Purchaser is located.

Prior to the extension of credit to the Purchaser named on the reverse side of this Credit Application Agreement, Northern Lakes Seafood & Meats, may at its sole discretion, require an Individual Personal Guarantee.
